Chris - We are not going to get everybody to agree on this.

Angela - We still need an attorney to do this.

Chris - All we have right now is \$2,000.00 in the bank and if an emergency can up we will be in trouble.

Angela – I am going to try to get Mr. Chris Davis, Attorney to come to the meeting to give his recommendation as to what we can do about this situation and then we well go on the regular presentation.

Chris - That well be great.
