Secretary Report

Minutes from the last Board meeting were read by Drew Mrenna. Upon motion made and seconded, the minutes were approved.

Treasurer Report

Kathy Olmert presented the Treasurer's report. There are eight delinquent property owners that have not paid their dues. Upon motion made and seconded, the treasurer's report was approved.

Kathy presented a proposed budget for 2007/2008.

Road Committee Report

The report highlighted one priority task – clearing a clogged drain pipe on Potomac Overlook. Roger may need to get outside help to clear this.

River Road needs some work. Culverts need to be cleared. Pot holes need to be filled.

In general there are several pot holes that need filled. It was discussed on what material to use to fill the pot holes. Stone does not stay. It was determined that the pot holes will be filled with shale and then tapped down. Roger is going to investigate the cost of shale.

The Board authorized \$3,500.00 to be spent on road maintenance for this year, of which approximately \$1,200.00 as already been spent. An additional \$500.00 was granted to cover the additional costs of clearing the clogged drain pipe.

A written report will be generated from the April 19th Road Committee meeting with an estimated costs. This report will be included with the minutes.

Open Issues

- 1. Signature authority has been updated for the checking account.
- 2. Nominations Vice Chair and Board Member are open for elections. Chris and Gene are willing to continue in their current positions. Jeff and Angie are also interested in the Board Member positions. A notice will also be included in the minutes. Drew was appointed to chair a nomination committee.
- 3. Excessive Speeds Signs are being proposed. The Board is researching the cost.
- 4. Property Assessment You may be able to lower your tax bill by combining adjoining properties into a single tax bill. More detail can be found at http://www.co.hampshire.wv.us/info.htm and look under COUSCLIDATIONS. You will need to contact the county tax office at 304-822-3326.

5. Bond – Kathy researched the cost of getting the Board members bonded. A \$10,000 bond costs \$114.00 annually and it covers all Board members. The Board agreed to purchase the \$10,000 bond. Kathy has completed the application process.

New Business

1. An ATV Issue was presented by Angela. Since the state regulates where ATVs can be used, the issue is a trespassing issue. These individuals claimed they were guest of members. Tom will draft a notice to send out to the members. Kathy made a suggestion to put up signs. Angie will investigate costs. Suggested wording is: "NO TRESPASSING, PRIVATE PROPERTY, NO ATV'S" on a florescent yellow background with black letters. Recommend placing three 24" X 24" signs. Also speed limit signs were recommended. Recommended wording: "MAX SPEED 25" on a florescent white background with black letters. Recommend 6 signs. Board will review after receiving costs.

By-Law review

Drew presented a summary of proposed By-Laws changes. A special meeting will be held on May 24 at 2:00 pm at Chris Fischer's house (Lot 19) to go into more detailed discussion.
