## <u>River Access Report</u>

- There are issues about trespassing. There have been confrontations at the river access. Per the covenants, the association only has river access only. There is no provision for picnicking on the access area.
- Discussed on removing picnic table and barbeque as this is providing an illusion that picnicking is permitted. Tom will call the property owners to discuss.

#### **By-Laws**
